

AGREEMENT BETWEEN ARCHAEOLOGICAL LEGACY INSTITUTE (ALI) AND

RELATING TO *STRATA* EPISODE FILM DISTRIBUTION VIA *HERITAGE*

Comune di SABBIONETA agrees:

1. That it legitimately possesses all right, title and interest in and to the film title in the Film Title Covered section, as stated below, including all patent, copyright, trademark, service mark, mask work, moral right, trade secret or other intellectual property or proprietary right (collectively, “Intellectual Property Rights”) therein.
2. To permit the film title listed below to be made available for consumer viewing through ALI via our subscription service, *Heritage Broadcasting Service* (HBS), in the form of an episode from **The Archaeology Channel** (TAC) video series, *Strata: Portraits of Humanity*. This confers upon ALI all right, title and interest in and to this film title as needed within the period of this agreement to distribute it through **The Archaeology Channel** and HBS as part of a *Strata* episode. This does not authorize ALI to distribute this title in any other manner or give ALI any other rights to this title.
3. To provide to ALI a digital file of the Italian version of the listed film, to be used for upload to the HBS server.
4. To incur no costs in providing content assets for the listed film to ALI, except for any costs associated with providing the digital file for the Italian version of that film.

Archaeological Legacy Institute (ALI) agrees to:

1. Employ a system for this online screening service that ensures protection against piracy to the maximum extent possible with up-to-date technology.
2. Make the listed title available to the public *gratis*, by placing it in the landing page highlighted, non-gated area of the *Heritage* platform, which is not behind any pay wall. This means placing access to this film, whose title is listed below, in the free of charge section of the *Heritage* web site, accessible to the public at no charge whatsoever. This is to make the this title viewable by the global public on a totally non-commercial basis. Consequently, no *Heritage* revenue will be generated by viewings of this film via *Heritage*, and no compensation shall be paid to Comune di SABBIONETA for any *Heritage* uses of this film, all of which shall be non-commercial uses.
3. Issue to Comune di SABBIONETA a quarterly report on the *Heritage* viewings of their film title, listed below, for each calendar quarter during the period of this agreement.

General Provisions

1. No costs whatsoever shall be charged by HBS or TAC to Comune di SABBIONETA, including costs of preparation, translation or technical adaptation for this film title.
2. This agreement is non-exclusive. Comune di SABBIONETA is free to make distribution agreements with others for the film title listed below.
3. This agreement initially extends for a two-year period from the date of the most recent signature below.
4. This agreement pertains to a worldwide sales territory unless specifically limited by one party to this agreement.
5. Either party to this agreement may withdraw the film title from the agreement at any time by providing two weeks' written notice to the other party via email or postal mail.
6. This document contains the entire agreement between Archaeological Legacy Institute and Comune di SABBIONETA.
